Dear Parents & Students:

The Ocean Springs High School Blue-Grey Pride Band is no stranger to the Walt Disney World Company. Once more, we have been invited, and accepted, to “Perform for the World” in the Magic Music Days Celebration. The band has had the distinct honor of being chosen to perform at Walt Disney World for 23 yrs. The band will be part of the Disney Cast and perform in the parade of “**Celebrate A Dream Come True**”. Trip dates are **May 27– June 1, 2012**.

The Walt Disney Company requires high standards of performance and style of its performers. By being accepted to perform, the band will become Cast Members for the day. Throughout our visit, the reputation of the Blue-Grey Pride and Ocean Springs High School is “onstage”. While I feel this is one of the finest groups I have had the pleasure of directing, I must also make sure it will uphold our reputation as a Disney Performer. I ask that you discuss with your student the proper conduct and manners while in public and on a performance trip. **Those students, who have had, or encounter, a problem with discipline will not be allowed to travel with the band.**

The cost of the trip is \$700.00. This price includes:

- ◆ **Transportation to and from Orlando, Florida**
- ◆ **4 nights in the All-Star Movies Resort**
- ◆ **3-day Park Hopper ticket (which includes all four Disney theme parks)**
- ◆ **1-day park hopper - Universal**
- ◆ **Blue Man Group Concert**
- ◆ **Performing Arts momento**

A **\$100.00 Non-refundable deposit** is due on **December 14, 2011**. The deposit is **non-refundable** due to the fact that I must send in one night’s payment per room to reserve the rooms. Once that deposit is made, **Disney will not refund**. Also, if one person pulls out of the trip for any reason, everyone else’s cost will go up. This deposit insures the cost will remain the same for all. If for some reason your student cannot attend the trip after payments have been made, only a percentage of the cost can be refunded. A “breakdown” schedule will be posted online at a later date at www.bluegreypride.com.

All funds raised beyond the trip cost will be given to the student, by the Treasurer, prior to the trip. These extra funds are only accessible for the band trip. Any and all funds raised from a band fund raiser remain the funds of the OSHS Band. These monies are not refundable.(state law)

Letter of Intent and Permission

I am also aware that a **NON-REFUNDABLE** deposit of \$100.00 is due by December 14, 2011 and trip cost is \$700.00. The balance must be **paid in full by April 1, 2012**. I also know that after **January 15, 2012**, only a percentage of personal funds deposited into student accounts can be refunded* and that all monies raised **through fund raisers** will remain the property of OSHS Band and cannot be refunded (state law).
